The City Council meets the first Tuesday of each month at 7:00 pm in the City Hall on Main Street in Georgetown. They welcome any and all visitors and are receptive to all suggestions for the betterment of our community.

With the City being incorporated, citizens are required to purchase building permits, license dogs, and conform to all ordinances passed by present and past City Councils. All ordinances and resolutions are available on the city website along with council minutes and community events. When purchasing dog licenses please bring proof of rabies shots and if you have over 5 dogs there is a separate kennel fee of \$25.00 as well. In addition to the website, the Ordinance book is available to all citizens and can be read and viewed during business hours. The City Hall is open on Tuesdays, Wednesdays, and Thursdays between the hours of 12:00 pm – 3:00 pm. I will be happy to help you with questions, concerns or problems during those hours. However, if you would like to personally talk to the Mayor or any of the council members you may do so at any time.

Enclosed you will find a payment booklet for the sewer and water facilities and a municipal services request form. Please read the form, sign it and return to me as soon as possible. You can also pay for your monthly water and sewer services on the website.

We are glad you have chosen Georgetown as your residence. We hope you will be happy here and life will be good to you. If you have any questions, please contact us; we will be happy to help you.

**MUNICIPAL WATER SYSTEM
SERVICES REQUEST**

I, the undersigned do hereby request water and sewer services for the property located at:

_____ in the City of Georgetown. I agree to conform to the ordinances, rules and regulations of said water and sewer system owned and operated by the City of Georgetown. I agree I am responsible for all repair and maintenance of City service lines located within my property boundaries. I, also, agree all sewer blockages from said property to the City main line are my responsibility. I understand all rates and charges for water and sewer services shall be due and payable by me, within ten (10) days after the first of the month and if not paid within thirty (30) days after the first day of each month, I will be considered delinquent and subject to any and all collection resources instituted by the City of Georgetown. I understand the City will continue to provide and charge for water and sewer services and I will be responsible for all charges for said services until written notice from me is received by the City. **All water connections to the City water system are required to have backflow prevention devices.**
